DESCRIPTION

Wall recessed or surface mounted dual patient station with individual cordset receptacles for use with remote call origination cordset. Removal of either cordset originates a call placement.

RECEPTACLES

Two cordset receptacles wired to accept 1/4" cordsets (normal call, geriatric, explosion proof) with nurse call origination facility.

CONTROLS AND INDICATORS

One or two combination white call placement indicator and call cancel button.

INSTALLATION

Color-coded, prewired terminations provided. Mount using only the two 6-32 x 1" nylon screws provided.

HOUSING AND FINISH

Faceplate: Flame retardant ABS plastic rated 94V-O by UL, finished in off-white supplied with nylon mounting screws.

W41 Backbox: metal backbox supplied by others.

DIMENSIONS

1-Gang Faceplate: 2-3/4" (6.99cm) wide x 4-1/2" (11.43cm) high.

2-Gang Faceplate: 4-9/16" (11.59cm) wide x 4-1/2" (11.43cm) high

The wall recessed or surface mounted dual patient station shall be for use with two remote call origination cordsets.

The patient station shall be provided with one or two white combination call placement indicator(s) and call cancel button(s). Two receptacles shall be provided to accept two 1/4" type cordsets. A call shall be originated if either cordset is removed from the receptacles.

The unit shall be provided with color-coded prewired terminations for ease of installation. The faceplate shall be flame retardant ABS plastic rated 94V-O by UL. Nylon screws shall be provided to mount the faceplate.

The unit shall be UL and CUL listed Hospital Signaling Equipment / Nurse Call Equipment under File E157381.

The faceplate shall be finished in off-white. The W41 backbox shall be supplied by others.
